The Journal was also made available online as an open access journal via the EAHIL website at <u>www.eahil.eu</u>. #### 9. EAHIL meetings

The 2016 Conference was held in Seville, Spain, on 6-10 June 2016, and hosted by the Health Ministry of Andalusia. By perfect coincidence, 2016 was also the 10th Anniversary of the Andalusian eHealth Library – so the conference was also a way of celebrating that significant milestone.

The theme of the conference was Knowledge, Research, Innovation ... eHealth!

The conference was well-organised, well-attended, and very well received. There were 360 delegates from 37 countries world-wide; there were 10 Continuing Education Courses in the days before the



conference; there were 10 parallel sessions on the various conference themes, with 57 oral presentations; there were 45 poster presentations across the various themes. In addition, there were 16 sponsor presentations, and 26 exhibitors.

For their excellent work in organising this conference, we owe thanks to Veronica Juan Quilis, Chair of the Local Organising Committee as well as Laura Muñoz Gonzalez and all members of the LOC team; as well as to Pilar Roque Castella, Chair, and Pilar Toro Sánchez-Blanco, Co-Chair, of the International Programme Committee, and all members of the IPC team.

The EAHIL Award 2015 was presented to Arne Jakobsson in recognition of his leadership of EAHIL as it matured as an association, and for his long-time support of colleagues' professional development. His beneficial influence was demonstrated by, for example, his encouragement of new entrants into the profession to attend our international conferences, and by leading the policy change of free membership, thereby lowering of barriers to membership of EAHIL and to access to our professional network.

The EAHIL Award 2016 was presented to Suzanne Bakker in recognition of her immense dedication to EAHIL over the decades – not only has she held various formal positions essential to the development of our association, but she has also been crucial to the running of many operational and infrastructural matters that are usually invisible.

The rare award of Honorary Member was presented to Sally Wood-Lamont, in recognition of and gratitude for the extraordinary contribution made to EAHIL, in particular through her leadership in developing the Journal of EAHIL from a newsletter into a journal, but also for her valuable efforts to improve communication and connect members – we miss having the EAHIL Echo at our conferences and workshops!

#### 13. Piloting online continuing professional development

Following a suggestion for webinars made at the 2015 Council meeting, during 2016 a working group was established to run a pilot programme of webinars between EAHIL's annual events. The aim of the pilot was to evaluate acceptability of online webinars to our members, and to evaluate processes and



mechanisms of organising and delivering webinars. The working group was tasked with gathering and reporting on experiences to allow the EAHIL Board to make informed policy and implementation decisions on offering online CPD. The first webinar took place in November 2016, with others scheduled in winter and spring 2017. The outcomes of the pilot will be reported in 2017.

### 14. Impact stories from members

Six members from four different countries sent in 'impact stories' for inclusion in this 2016 report. A combined summary of the points made by those members is presented here.

The strongest theme that comes through all the impact stories is EAHIL's value as an international professional network:

"the main point I want to make here is that for me EAHIL has been and is the portal to network internationally"

For medical librarians living and working in European countries, EAHIL provides an easy way to build a network of contacts throughout Europe. Medical librarians working in other parts of the world without well-established professional networks have found opportunities for professional development by participating in EAHIL events:

"The EAHIL group has allowed me to know new sites, participate in virtual meetings ... and the most important, to know about how biomedical librarians are doing remarkable work... European medical librarians have many steps advanced in this matter so it's important and urgent follow the path they are showing us"

The professional network acts as a foundation that supports other benefits highlighted in the stories. The network allows members to learn new ideas and learn from others' contexts, skills and current work.

"Participating in conferences, workshops, CECs, webinars, reading the journal, following Facebook... Knowing what others are doing also (in a good way) pushes to take new challenges and initiatives yourself!"

EAHIL conferences and workshops are really special – "The trip to EAHIL conference/workshop is always one of the highlights of the year!" – but attending an event has lasting effects:

"to focus on the impact in 2016: we have had some hard times in our organization, so the excellent opening lecture by professor Bernat Soria "On the value of knowledge" in the Seville conference was right on the spot! Something to come back to through the year."

Participating in EAHIL events can challenge us to think in new ways and to do new things we've never done before; ideas and contacts made from one event can give the confidence and support leading to publications, collaborations, research projects and presentations at future conferences.

"...it changed my views and thoughts about research and how as working librarians we can incorporate research within our day to day practice. I met and listened to some very inspiring people and I soon realised that you can carry out and publish research within your own workplace. Indeed, through talking to colleagues at the conference, I had the opportunity to write for the Health and Information Journal – something which I do not think would have happened if I had not attended the conference."

Involvement in publications, as a result of connections made at conferences, was also described in another impact story.



Outside EAHIL events, the Association is a resource for finding "responsive and aware partners for professional experience exchange through ERASMUS staff mobility programme." We also see independent fruitful collaborations that have a direct impact on increasing our knowledge, broadening our experiences and improving the services and facilities we provide:

"The EAHIL network has helped in benchmarking between libraries and made possible for example a site visit [...] that gave both inspiration and practical ideas for furnishings and flexible study space."

The impact stories also show that EAHIL provides more than new ideas and professional development - the people in the network are special, too:

"But not only professional issues I would like to prioritize. Human relations is very important for me too. Since 2009 I got acquainted with many amazing people from many countries."

As you can see from the last quoted extract, the impact stories did not adhere strictly to talking about 2016: a clear message is that for these members, long-lasting personal friendships and professional connections are created within EAHIL.
