## Professional background

I have been developing my professional expertise in the area of information science and digital libraries for more than 15 years. Currently I work at the Spanish Foundation for Science and Technology (FECYT) in Madrid (Spain) as National Open Access Desk National for the OpenAIRE project, providing support to libraries and researchers about open science and research data management. Before that, I was Research & Scholarly Communications Information Manager at the University of Hertfordshire (UK), where I delivered support and training in open access, research data, research evaluation and metrics, as well as guidance on publication strategy and research intelligence. Prior to that I was Head of the Library and Information Service at the Spanish National Cardiovascular Research Centre in Madrid (Spain), where I was in charge of the library management, including acquisitions, license agreements, repository development, research support, and delivered bibliographic searches and biomedical information.

I hold a PhD in Linguistics on Medical Terminology from the University of the Basque Country, a Master in Digital Libraries and Information Services from the Carlos III University of Madrid, and a Bachelor's degree in Translation and Interpreting.

I speak Spanish, English, German and French fluently; and due to the periods I was settled in France, Germany, Austria, and in the UK, I have not only the linguistic knowledge but also the understanding of cultural differences and diversity, which can be an asset connecting people from different countries.
