#### **Minutes**

## 3. Minutes of the 2020 Council Meeting in Lodz

## 4. President's report

The report for 2020 was available at the EAHIL web site and the URL circulated together with the agenda. The members were asked to read the report before the meeting. ### 5. Individual councilors: news and reports

There was one question from Fatemeh Sheikh, Iran. She asked about the conditions for becoming a Council member. The President stated that Council members are elected only from European countries, but that others are welcome as members of EAHIL.

# 6. Interactive session

#### 7. Information from the EAHIL Board

The Board had a pre-conference meeting 5 July where finance, communication, systems development etc were on the agenda. The need for a new membership database, with better functionality for members to log on and update their records, for voting at elections etc was also discussed. Tips and suggestions for good software and solutions are welcome.

Ebsco has paused their financial support for the scholarship from 2022. EAHIL therefore needs a new scholarship sponsor, preferably for a period of three years.

More activity on the communication platforms is needed, to make EAHIL more visible on social platforms and among the members and also to strengthen the dialogue between the different forums of EAHIL. The Board strongly encourage content from members, subgroups etc. Short reports from the Board meetings will be published on the web site blog.

Bids for EAHIL Conferences and Workshops are needed and welcomed from 2024 and the following years.
